1. Research and Advocacy Responsibilities

- I led the gender project in this Judicial Governance unit, and my primary focus was gender equality in the legal sector. I oversaw and coordinated various research, advocacy initiatives, and regional and international engagements that included facilitating and presenting at workshops and conferences in Southern, East, West Africa, the United States, Canada, and Hong Kong.
- I conducted legal research, empirical fieldwork, and analysis as part of a project on judicial appointments and the rule of law. The result was in-depth reports, policy recommendations, briefing notes for governments, multilateral funders, and judicial stakeholders, and material for relevant regional bodies such as the Southern African Chief Justice's forum.
- I worked on projects funded by and engaged with international organizations such as the Norwegian embassy, USAID, UNODC, Open Society Foundation, and Ford Foundation. These projects required that I organize or assist at various workshops, leadership training, and symposia as part of my responsibilities.
- I had a significant advocacy component, which entailed forming partnerships with members of Civil Society Organisations. We worked together to achieve common goals regarding strengthening the courts and access to justice, supporting good governance and equitable representation of women in judiciaries, the legal profession, and judicial appointing bodies. I also facilitated at Judge's forums organized by my unit, interacting with Magistrates and Legal professionals nationally, regionally, and internationally.
- I conducted workshops for women in the legal sector and provided technical assistance to the Judges Matter Coalition and the South African Chapter of the International Association of Women Judges.

This involved mentoring the law students and pairing them with women judicial officers, running and facilitating weekend writing and leadership retreats, and running skills acquisition programmes.
